



Competition Agreement 2017 (14u)

This document, between the Committee of the Southern California International Softball Festival Champions Cup, acting on behalf of the 2017 Champions Cup (14u) tournament, and _____ (team name) is a binding contract that specifies, in part, the terms by which the team listed above will be certified to compete in the 2017 Champions Cup (14u) tournament. These terms (requirements) include:

- I. **Entry Fees** – The 2017 Champions Cup (14u) entry fee is **\$775.00**. All entry fees are due upon acceptance into the tournament. Payment may be made by check or money order, payable to **The Champions Cup**. Once a team is accepted and the check is cashed **no refunds will be issued**.

Deadlines – Paperwork **NO LATER** than dates below (early is good) **mail PAPERWORK PLEASE**

- (1) _____ **May 5, 2017** --- **PROOF of ASA registration (receipt registration or Bollinger Insurance Certificate)**
- (2) _____ **May 19, 2017** – **Hotel Confirmation Form (2017 16u) (form – hotel chosen and number of rooms reserved) out of area only**
- (3) _____ **June 5, 2017 #1 Team Roster Form #2 Summary of Wrist Band by Graduation Year (f/ College Coaches Booklet)**

- II. **Disqualification** – The Champions Cup (14u) reserves the right to remove an individual or team from competition at any time due to conduct considered detrimental or harmful to the ideals or spirit of the Champions Cup (16u), its staff, volunteers, officials, fans, or other participants.
- III. **Withdrawal** – In the event that any team has not qualified for their national championship tournament and is entered in a national championship qualifying tournament during the same time as the Champions Cup (14u), that team must either confirm their withdrawal from the national qualifying tournament by **Monday, June 5**, or they will be removed from the Champions Cup (14u) on that date and replaced with a team from the waiting list. The Champions Cup (14u) is not responsible for any costs or cancellation penalties incurred by any team removed from the tournament under this provision.
- IV. **Hotels** – The Champions Cup (14u) requires that all participants are bound by the terms as stipulated in their Hotel Agreement. Failure to comply will result in immediate and/or future exclusion from the tournament.
- V. **Coach/Managers Meeting – Option to attend - - Tuesday, July 12, 2016 (additional fees required)**
- VI. **Completion of Competition** – All teams must agree to complete all games assigned to them, both in pool play, elimination bracket and championship play. Please be aware that the championship game is scheduled to begin **at (4:30 pm) on Sunday, 9th of July**. All teams are required to make travel arrangements that will allow them to complete the tournament, up to and including the championship game
